2026 Head Start Program

January 13, 2026 - January 26, 2026

The 2026 Head Start Program is available to all current participants of the Excursion and Preferred programs. Eligible participants can submit up to ten (10) transactions (one-way or round-trip) according to the guidelines outlined below. To participate, accounts ending in an **odd number** (1, 3, 5, 7, or 9) must be updated by **December 31, 2025**. While late applications will be accepted, we cannot guarantee that they will be processed in time for the program.

Head Start reservation guidelines:

- You may make up to ten (10) reservations in your name for personal use.
- Up to five (5) of these reservations may be made in another individual's name for personal use.
 - Of these five (5), up to three (3) reservations may be requested as transferable, which can be transferred to another individual at a later time.

Transferable reservations must be transferred no later than **30 days prior to the booking date**. If not transferred by this deadline, the reservation will be canceled automatically, and the space released. A \$10 cancellation fee will apply.

Note: All reservations must be prepaid, and the payment method cannot be changed once processed. After processing, you will receive a confirmation by email or postal mail, depending on your preference. Please verify that the dates, times, and destinations are correct. Any discrepancies must be reported immediately. Failure to do so will result in acceptance of the confirmation as sent.

Please Note: Submitting your request early does not improve your chances of securing your preferred reservation. All requests received before January 13, 2026, will be randomly processed prior to any submissions received after that date.

Important dates for 2026 reservations

January 13-19, 2026: Non-transferable reservations only

During this period, Preferred and Excursion account holders can book reservations only for their personal use. No transferable or third-party reservations will be accepted.

January 20-26, 2026: Transferable and non-transferable reservations

Both transferable and non-transferable reservations, including third-party bookings, will be accepted. Reservation requests received by 4 p.m. on January 26, 2026, will be given Head Start priority. If your preferred time is unavailable, the closest available option will be booked. Please complete the travel options section on your Head Start form to help us secure the best possible time for you. You may also request to be waitlisted for your preferred time.

Online Head Start reservations

Starting at 8:00 a.m. on January 13, 2026, you can make reservations online at www.steamshipauthority.com. To log in, you will need your account number (formerly profile number) and PIN or your username and customer code.

Mailed requests received by January 13, 2026, will begin processing at the start of business on January 13, 2026. Submissions received after that will be processed in the order they arrive.

General public opening dates

- 8 a.m. January 27, 2026: Nantucket general public bookings (online/postal mail only)
- 8 a.m. February 3, 2026: Martha's Vineyard general public bookings (online/postal mail only)
- **February 10, 2026:** Reservations can be made by phone or in person at a terminal on both routes

Extended season opening dates:

- June 16, 2026: Fall 2026 (October 22, 2026 to January 5, 2027)
- October 20, 2026: 2027 Winter/Spring (January 6, 2027 to T.B.D.)

Extended Hours & Blue Line Standby*

(*Martha's Vineyard Route ONLY)

2026 MARTHA'S VINEYARD EXTENDED HOURS FOR RESERVATION ONLY PERIODS

No standby travel will be permitted through March 31, 2026, on the Woods Hole-Martha's Vineyard route. A decision on standby travel for the remainder of the year will be made in early 2026; please watch www.steamshipauthority.com for details.

Regardless of the extension of year-round reservation-only travel, the Reservation Office will offer extended phone service from 7 a.m. to 7 p.m. for same-day travel needs as follows.

- Every Friday, Saturday, Sunday and Monday from June 19, 2026, to September 7, 2026.
- May 21-26, 2026
- June 30-July 2, 2026
- September 8, 2026
- October 9, 2026
- October 12, 2026

The Blue Line is offered to Excursion and Preferred customers these days as available.

*Only same day reservations or high-speed reservations will be processed outside of the hours of 7:30 a.m.-4 p.m. EST.

Reservation-Only Travel and Blue Line information for Martha's Vineyard

If you are a Preferred or Excursion customer, however, you can access the Blue Line for your last-minute travel needs.

What is the Blue Line? Think of it as an islander standby line. On Reservation-Only Days at the Woods Hole and Vineyard Haven terminals, up to 12 cars at a time can be placed in the Blue Line for standby travel.

Who can use the Blue Line? You must be a current Preferred or Excursion program customer to access the Blue Line.

Is the Blue Line always available? No, the availability of the Blue Line can be paused or suspended at any time by the terminal agent on duty based on vehicle space needs at our terminal.

Do I have to give up a reservation to join the Blue Line? Not anymore! If you're trying to travel earlier than your reservation on the day of your travel, you do not have to give up your reservation.

What if I have a medical appointment? Please follow our established procedures for traveling for a routine medical appointment.

What if I have an emergency medical or family situation? Please call the Reservation Office or go to the terminal ASAP and speak to the manager or agent on duty.

What are some tips for Blue Line travel?

- Have an updated Preferred or Excursion account. Make sure your vehicles are correct and current and verify your contact information is correct.
- When the check-in booth gives you a Blue Line placard, please make sure it is visible to the terminal staff.
- Keep an eye on our website for weather and operational updates. If trips are canceled, the Blue Line may be suspended until those reservations are accommodated.
- Do not park or hover in the pick up or drop-off areas if you are waiting to get into the Blue Line.
- Do not call the Reservation Office unless you are trying to book travel—they will not be able to help you get into the Blue Line.

- Bring your patience and your kindness! This will be a challenging adjustment for everyone, including our staff, but we will continue to assess and adjust this process as we learn from its use.
- You can now see the Blue Line status on the home page of the website under "Parking Information and Current Status"
- We are also using a call-back system when the Blue Line is full to alert customers when they can return to the terminal to be staged.
