Mr. Bidwell,

I am reaching out and advising that your company's license agreement contains the following provision under Article 17:

Licensee expressly agrees that nothing in this Agreement, whether standing alone or in combination with other events, agreements, instruments, documents or understandings, entitles Licensee to any extension of the Services beyond October 12, 2021, and that the Authority shall in no way be obligated to license Licensee to operate any transportation service after October 12, 2021. Any license for services subsequent to October 12, 2021 may be granted only by an instrument of equal formality signed by the duly authorized representatives of the respective parties.

I am also attaching a copy of the Authority's licensing policy [which you may already have] for your review and consideration. Please see pages 20 through 22 for the license renewal procedure. The fundamental issue is whether Island Commuter is proposing any "material change[s]" to its previously licensed service.

We look forward to receiving and reviewing your service proposal.
